The 2012-2013 attendance report showed that 50% of the members would not meet this target.

The committee will be issuing a membership survey (sample attached) to get a feel for what would help retain our current members. Once the survey was out, board members could follow-up with non-respondents by telephone.

The committee will be focusing on retention over recruitment.
